Being a By-law to amend By-law Number 6000-17, as amended, to make a Number of Housekeeping and Technical Corrections

Whereas under section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended (the "Planning Act"), zoning by-laws may be passed by the councils of local municipalities to prohibit and regulate the use of land, buildings, and structures,

And whereas the Council of the Town deems it necessary and expedient to further amend the Zoning By-Law,

Now therefore the Council of The Corporation of the Town of Aurora hereby enacts as follows:

1. Section 4.20 of the Zoning By-law be deleted and is hereby replaced as follows:

4.20 Yard Encroachments Permitted

The structures listed in the following table shall be permitted to project into the minimum yards indicated for the distances specified:

- 2. Section 5.6.1 be amended by adding the following sentence:
 - 5.6.1(g) All areas in the front yard other than the *driveway* shall be *landscaping* open space
